Delivery of the Goods is required within Thirty (30) calendar days upon receipt of Notice to Proceed (NTP). Bidders should have completed within a twelve (12) month period between 2013

to the present from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

Interested bidders may obtain further information from the NATIONAL FOOD AUTHORITY and inspect the Bidding Documents at the address given below from 8:00 a.m. to 5:00 p.m.

A complete set of Bidding Documents may be acquired by interested Bidders on May 21, 2017 to June 13, 2017 (working days only) from the address below and upon payment of a non-refundable bidding fee for every lot as specified in this Invitation.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

The NFA will hold a Pre-Bid Conference on May 29, 2017 @ 10:00 A.M. at the National Food Authority, Regional Office 8 Conference Room, Pawing, Palo, Leyte, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below on or before 10:00 A.M. on June 13, 2017. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18 or a Bid Securing Declaration (BSD).

Bid opening shall be on June 13, 2017 at 10:01 A.M. at the National Food Authority, Regional Office 8 Conference Room, Pawing, Palo, Leyte. Bids will be opened in the presence of the bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.
