2. The NFA Cagayan Valley Region now invites bids for the "**PROCUREMENT OF 2022 CAPITAL OUTLAY PROJECTS-MACHINERIES AND EQUIPMENT FOR THE FIRST SEMESTER**". Bidders should have completed within the last **three (3) years** a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "Pass/Fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines where a foreign investor is involved.

4. Interested bidders may obtain further information from **NFA Cagayan Valley Region**, and inspect the Bidding Documents at the address given below during office hours (8:00 AM to 5:00 PM).

5. A complete set of Bidding Documents may be acquired by interested Bidders on **February 16 to March 8, 2022 (Excluding Saturdays, Sundays and Holidays)** from the address below and upon payment of the non-refundable fee as indicated above per lot.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the National Food Authority (NFA), provided that Bidders shall pay the applicable non-refundable fee for the Bidding Documents not later than the submission of their bids.

6. The NFA Cagayan Valley Region will hold a Pre-Bid Conference on February 23, 2022, 9:30 AM at the NFA Multi-Purpose Hall, Mabini, Santiago City, which shall be open to prospective bidders.

9. Bid opening shall be on **March 8**, 2022 after the 9:30 AM deadline for the submission of bids at the given address. Bids will be opened in the presence of the bidders' representatives who choose to participate in the activity.

The **NFA Cagayan Valley Region** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
