- 1. Letter of Intent to Participate in the SMDP signed by the licensee or Grains businessmen, and for F.O.'s, the Chairman or President.
- 2. Certified photocopy of the Certificate of Grains Business License, license plate, sticker and official receipt of payment of license fees valid as of December 2010 and/or as of 2011.
- 3. Certified photocopy of the valid City/Municipal License/Business Permit if engaged in the grains business.
- 4. Photocopy of the Master's Passbook valid as of December 2010 and/or as of 2011 as certified by the NFA Provincial Manager.
- 5. Certificate of Membership to be issued by the PFAB Chairman or the PFAC Chairman in the Province where the Farmer-Organization is located as designated by PFAB or Certificate of Membership to be issued by NAFC Chairman or Provincial NAFC as designated by the NAFC National chairman or President of the Irrigators' Association.
- 6. Certified photocopy of the Certificate of Registration issued by the Regional/Provincial Office of the Cooperative Development Authority (CDA) whichever is applicable.
- 7. Photocopy of the Retailer's Passbook issued by the NFA as certified by the NFA Provincial Manager.
- 8. Certified photo copy of the SEC Registration Certificate, for corporations
- 9. Certified photo copy of the DTI Registration Certificate, for sole proprietorship and partnership.
- 10. Special Power of Attorney (SPA) for the representative, if sole proprietorship/partnership business and/or Board Resolution or Secretary's Certificate, if corporation/cooperative indicating that they are authorized to purchase SMDP documents, attend the pre-SMDP conference and the conduct of the SMDP proper (submission and opening of bids) and all other activities related thereto, such as, to sign documents on the withdrawal of stocks in the NFA warehouses like Warehouse Stock Issue (WSI), receive the stocks for and in behalf of the bidder. The authorized representative shall be limited to the immediate members of the family for sole proprietorship/partnership business and an officer or official of the company/corporation, if corporation, and a Board of Director in the case of Farmer-Organization (F.O.).
- 11. No single person to be covered with SPA shall be allowed to represent more than one entity.
- 12. For IBSP retailer-member, certified photocopy of the IBSP passbook issued by NFA as certified by the NFA Provincial Manager and certified photocopy of the Deed of Undertaking executed by the members of the IBSP prior to the operation of the IBSP as certified by the Provincial Manager.

Any left out volume not disposed during the scheduled bidding/SMDP on March 6, 2013 shall be subjected for another bidding on March 8, 2013 at the same time and venue and every Tuesdays and Thursdays thereafter until all stocks are sold.

New buyers/bidders may participate in the SMDP, provided they submit the required documents and pay the non-refundable bidding fee.

VII. BID BOND AND PERFORMANCE BOND

- 1. The bid offer (Tender Form) must be accompanied by a BID BOND equivalent to TEN PERCENT (10%) of the total amount of bid/offer in the form of CASH, CASHIER'S/MANAGER'S CHECK payable to the NFA issued by any reputable commercial bank. The CASHIER's/MANAGER'S CHECK must be accompanied by an Application to Purchase CASHIER's/MANAGER'S CHECK duly signed and approved by the bank manager and official receipt or machine validation of payment. Further, CASHIER'S/MANAGER'S CHECK shall be subject for the confirmation by the issuing bank before an NFA Official Receipt is issued to the bidder.
- 2. The application to purchase Manager's/Cashier's Check must be secured by the bidder and withdrawn from the account of the bidder in the issuing bank, otherwise, the bid bond shall be rejected and the bidder disqualified. The application to purchase Manager's check/Cashier's check shall also be submitted to the SMDP Secretariat.
- 3. No Manager's/Cashier's check secured by and withdrawn from the account of any other person or persons submitted as bid bond by the bidder shall be accepted during the opening of the bids.
- 4. Forfeiture of the Bid Bond shall include among others, withdrawal of bid during the period of bid validity, refusal to accept correction of mathematical errors on bid price, refusal to accept award, etc.
- 5. The Bid Bond shall be converted into Performance Bond of the Winning Bidder.
