INVITATION TO BID FOR THE CONSTRUCTION OF 45,000 BAGS CAPACITY WAREHOUSE IN BANTAY, ILOCOS SUR (REBIDDING)

PROJECT REFERENCE NO.: ITB-RBAC-RO1-2017-07-016

1. The National Food Authority, through its Capital Outlay Fund for 2017 intends to apply the sum of **PESOS: FIFTEEN MILLION ONE HUNDRED NINETY THREE THOUSAND ELEVEN AND 19/100 (P15,193,011.19) ONLY**, inclusive of VAT, being the Approved Budget for the Contract (ABC) to payments under the contract for the **Construction of 45,000 bags Capacity Warehouse in Bantay, Ilocos Sur**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *National Food Authority* now invites bids for the *Construction of 45,000 bags Capacity Warehouse in Bantay, Ilocos Sur* with the following Approved Budget for the Contract and cost of bidding documents:

The prospective bidder should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II, Instruction to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from NFA Region 1 and inspect the Bidding Documents at the address given below **from 8:00 AM to 5:00 PM on July 21, 2017 to August 13, 2017 (excluding Saturdays, Sundays and Holidays)** and **from 8:00 AM to 10:00 AM on August 14, 2017**.

5. A complete set of Bidding Documents may be acquired by interested bidders on **July 21, 2017 until August 14, 2017** from the address given below and upon payment of the applicable fee for the Bidding Documents pursuant to the latest Guidelines issued by the GPPB, in the amount of **PESOS: Twenty Five Thousand and 00/100 (P25,000.00)** only.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) (www.philgeps.gov.ph) and the website of the National Food Authority (www.nfa.gov.ph), provided that Bidders shall pay the applicable fee for the Bidding Documents as stated above not later than the submission of their bids.

6. The **National Food Authority** will hold a **Pre-Bid Conference** on **July 31, 2017; 10:00 AM** at the **NFA Regional Office 1 Conference Room, Urbiztondo, San Juan, La Union** which shall be open to all prospective bidders.
7. Bids must be duly received by the RBAC Secretariat at NFA Regional Office I, San Juan, La Union on **August 14, 2017; not later than 10:00 AM**. All bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in the Instruction to Bidders (ITB) and BDS Clause 18.1.

Bid opening shall be on **August 14, 2017, 10:01 AM onwards** at the NFA Regional Office 1 Conference Room, San Juan, La Union. Bids will be opened in the presence of invited observers and to all bidder/s (or authorized representative/s) who choose to attend the bidding. Late bids shall not be accepted.

8. The National Food Authority, Region I reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
