**INVITATION TO BID**  
**NFA REGION VIII SECURITY SERVICES REQUIREMENT**  
**for February 1, 2017 to December 31, 2017**  
Project Reference No RO8-2016-029 - GOODS

The *National Food Authority, Regional Office 8, Pawing, Palo, Leyte*, through the CY 2017 Corporate Fund intends to apply the sum of **Fourteen Million Seven Hundred Twenty-Four Thousand Eight Hundred Sixty-Four Pesos Only (P14,724,864.00)** inclusive of VAT, being the Approved Budget for the Contract (ABC) to payments under the contract for the provision of security services of NFA Region VIII for eleven (11) months, Project Reference No RO8-2016-029 - GOODS. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The *National Food Authority, Regional Office 8* now invites bids from DTI/SEC/CDA registered Security Agencies for the provision of security services requirement of NFA Region VIII. Delivery of the services is required from February 01 2017 to December 31, 2017. Bidders should have completed within the last three (3) years from date of submission and receipt of bids, a contract similar to the Project equivalent to at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested bidders may obtain further information from the *National Food Authority, Regional Office 8* and inspect the Bidding Documents at the address given below during the office hours from 8:00 A.M. to 5:00 P.M.

A complete set of Bidding Documents may be acquired by interested Bidders or through their duly authorized representatives starting December 29, 2016, weekdays only from 8:00 am to 5:00 P.M. and not later than 9:00 A.M. of January 18, 2017 from the address below and upon payment of a non-refundable fee for the Bidding Documents, pursuant to latest Guidelines issued by the GPPB, in the amount of Twenty Five Thousand Pesos (P25,000) in cash only.



It may also be downloaded and reprinted free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPs) ([www.philgeps.net](http://www.philgeps.net)) and the website of the National Food Authority ([www.nfa.gov.ph](http://www.nfa.gov.ph)), provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

The **National Food Authority, Regional Office 8** will hold a Pre-Bid Conference on **January 6, 2017, 9:00 A.M. at NFA Regional Office Conference Room, Pawing, Palo, Leyte** which shall be opened only to all interested parties who have purchased the Bidding Documents.

Bids must be delivered to the address below on or before January 18, 2017 at 9:00 A.M. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18 or a submission of Bid Securing Declaration.

Bid opening shall be on January 18, 2017 at 9:01 A.M. at the NFA Regional Office VIII Conference Room, Pawing, Palo, Leyte. Bids will be opened in the presence of the Bidders or their authorized representatives who choose to attend at the address below. Late bids shall not be accepted.

The **National Food Authority, Regional Office 8** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.


