# VI. <u>HOW TO BID</u>

All bids that exceed the ABC shall be rejected outright.

## VII. CONDITIONS IN THE DETERMINATION OF THE LOWEST CALCULATED BID

In case of a tie in the Lowest Calculated Bid (LCB) between two bidders, this shall be resolved through toss coin. In case of multiple ties, it shall be resolved through draw lots.

# VIII. PERFORMANCE SECURITY

The Performance Security shall be in amount not less than the required percentage of the total contract price in accordance with the following schedule:

# IX. WARRANTY

The contractor shall acknowledge receipt and assume full responsibility on the transformers from the time of disconnection and pick up at NFA La Union compound, San Juan, La Union up to the installation/commissioning of the newly repaired/refurbished units.

To ensure that defects shall be corrected by the contractor, the units shall be covered by a warranty of a minimum of one (1) year after the installation/commissioning.

## X. OBLIGATIONS OF THE CONTRACTOR

- 1. The contractor shall conduct inspection on the three (3) units 37.5 kVA distribution transformer at NFA Regional Office compound San Juan, La Union prior to the submission of price quotation.
- 2. To disconnect and pick up the units for repair at NFA Regional Office compound San Juan, La Union upon receipt of the Notice to Proceed.

- 3. To provide all labor and materials needed in the repair/rewinding of two (2) units 7,620/13,200 120/240V, 37.5 kVA distribution transformers and refurbishing of one (1) unit 7,620/13,200 120/240V, 37.5 kVA distribution transformer.
- 4. To deliver the newly repaired/rewind and refurbished units within thirty (30) calendar days upon receipt of the Notice to Proceed, to La Union Electric Company ( LUECO) , San Fernando, La Union for the conduct of testing in compliance to local electric company's standard operating procedure.
- 5. To personally or through his authorized representative, witness the testing to be conducted by LUECO and to be present during the installation/commissioning of said items.
- 6. To secure at contractor's own expense the transformer test results from LUECO, San Fernando City, La Union.
- 7. After the conduct of the testing, the units shall be subsequently delivered to the project site at NFA Regional Office compound, Brgy. Urbiztondo, San Juan, La Union together with a DENR Polychlorinated Biphenyls (PCB) Certificate. Delivery shall be covered by Charge Invoice and Delivery Receipt.
- 8. All expenses, losses and damages which may be incurred while the item for delivery is in transit to LUECO Testing Laboratory and the project site shall be borne by the supplier.
- 9. Contractor shall bill NFA upon completion of the works and after the complete submission of the required documents as mentioned in item XI.4.

# XI. OBLIGATIONS OF THE NFA

- 1. To issue a Purchase Order simultaneous with the Notice of Award.
- To serve the Notice to Proceed indicating therein the description of the project and location.
- 3. The NFA Inspection Team to inspect the units, witness the conduct of testing at LUECO Testing Laboratory in San Fernando City, La Union and witness the commissioning/energizing of the three (3) units 7,620/13,200 120/240V, 37.5 kVA transformer for NFA La Union Compound.

Should there be defects, non-conformity with specifications and any other reasons for rejection, the NFA shall notify the contractor immediately thereof.

# XI. LIQUIDATED DAMAGES

Where the contractor refuses or fails to satisfactorily complete the work within the specified contract time plus any time extension duly granted and is hereby in default under the contract, the contractor shall pay the procuring entity for liquidated damages and not by way of penalty, an amount equal to at least one tenth (1/10) of one percent (1%) of the cost of the unperformed portion of the works for every day of delay.
