RECOMMENDING THE AWARD OF CONTRACT TO ST. FRANCIS XAVIER
STAR SHIPPING LINES, INC. FOR THE PROCUREMENT OF SHIPPING,
TRUCKING, AND OTHER PORT SERVICES FOR THE TRANSFER OF 10,000
BAGS OF NFA RICE AND VARIOUS OFFICE
SUPPLIES/MATERIALS/EQUIPMENT FROM THE PORT OF MANILA TO NFANCR CDBO BATANES WAREHOUSE FOR CY 2025

WHEREAS, the National Food Authority – National Capital Region (NFA-NCR) posted the Invitation to Bid (ITB), including the bidding documents for the procurement of Shipping, Trucking, and Other Port Services for the transfer of 10,000 bags of NFA rice and various office supplies/materials/equipment from the Port of Manila to the NFA-NCR Central District Branch Office (CDBO) Batanes Warehouse for CY 2025, from June 18 to 30, 2025, through the following platforms:

- 1. Philippine Government Electronic Procurement System (PhilGEPS);
- NFA Official Website;
- A conspicuous place reserved for the purpose within the premises of the NFA.

WHEREAS, on June 20, 2025, a Pre-Bidding Conference was conducted and attended by the following prospective bidders:

- 1. St. Francis Xavier Star Shipping Lines, Inc.
- Counterflow Movers, Inc.

WHEREAS, on July 1, 2025, during the scheduled bidding activity, only St. Francis Xavier Star Shipping Lines, Inc. submitted a bid;

WHEREAS, the bid submitted by St. Francis Xavier Star Shipping Lines, Inc. passed the preliminary examination of bids and was subsequently declared an eligible bidder;

WHEREAS, on July 3, 2025, following the results of the detailed bid evaluation, St. Francis Xavier Star Shipping Lines, Inc. was declared as having submitted the Single Calculated Bid (SCB);

WHEREAS, in accordance with Section 34, Rule X (Post-Qualification) of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, the bid of St. Francis Xavier Star Shipping Lines, Inc. was subjected to post-qualification from July 4 to 7, 2025, to verify, validate, and ascertain whether the bidder is legally, technically, and financially capable to undertake the procurement.

and whether its bid is responsive to all the requirements and specifications stated in the bidding documents;

WHEREAS, on July 7, 2025, during the post-qualification deliberation, the Regional Bids and Awards Committee (RBAC) concurred with the findings and recommendation of the Technical Working Group (TWG), which conducted the post-qualification, that St. Francis Xavier Star Shipping Lines, Inc. is legally, technically, and financially capable to undertake the project, and thus declared the bidder as having submitted the Single Calculated and Responsive Bid (SCRB);

NOW, THEREFORE, we, the members of the NFA-NCR RBAC, hereby RESOLVE, as it is hereby RESOLVED, to recommend to the Head of the Procuring Entity (HoPE) the issuance of the Notice of Award, execution of Contract and Issuance of Notice to Proceed to St. Francis Xavier Star Shipping Lines, Inc. for the procurement of Shipping, Trucking, and Other Port Services for the transfer of 10,000 bags of NFA rice and various office supplies/materials/equipment from the Port of Manila to the NFA-NCR CDBO Batanes Warehouse for CY 2025, in the total amount of One Million Nine Hundred Sixteen Thousand Seven Hundred Twelve Pesos (₱1,916,712.00).



CONTRACT AGREEMENT

THIS AGREEMENT made on the 28th day of July, 2025 between NATIONAL FOOD AUTHORITY-NATIONAL CAPITAL REGION of the Philippines (hereinafter called "the Entity") of the one part and ST. FRANCIS XAVIER STAR SHIPPING LINES INC., National Road, Brgy. Kaychanarianan (hereinafter called "the Supplier") of the other part;

WHEREAS, the NATIONAL FOOD AUTHORITY-NATIONAL CAPITAL REGION invited Bids for certain goods and ancillary services, particularly SHIPPING, TRUCKING AND OTHER PORT RELATED SERVICES FOR THE TRANSFER OF 10,000 BAGS OF NFA RICE AND VARIOUS OFFICE SUPPLIES/MATERIALS/EQUIPMENT FROM PORT OF MANILA TO NFA-NCR CDBO BATANES WAREHOUSE FOR CY 2025 and has accepted a Bid by the Supplier for the shipping, trucking of those goods and services in the sum One Million Nine Hundred Sixteen Thousand Seven Hundred Twelve Pesos (₱1,916,712.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - Philippine Bidding Documents (PBDs);
 - Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of One Million Nine Hundred Sixteen Thousand Seven Hundred Twelve Pesos (₱1,916,712.00) or such other sums as may be ascertained, ST. FRANCIS XAVIER STAR SHIPPING LINES INC., agrees to the SHIPPING, TRUCKING AND OTHER PORT RELATED SERVICES FOR THE TRANSFER OF 10,000 BAGS OF NFA RICE AND VARIOUS OFFICE SUPPLIES/MATERIALS/EQUIPMENT FROM PORT OF MANILA TO NFANCR CDBO BATANES WAREHOUSE FOR CY 2025 in accordance with his/her/its Bid.

The NATIONAL FOOD AUTHORITY-NATIONAL CAPITAL REGION agrees to pay the above-mentioned sum in accordance with the terms of the Bidding. 
