Negotiated Procurement will be conducted through Small Value Procurement under the revised IRR of RA 9184, otherwise known as the "Government Procurement Reform Act".

Scope of Work and Specifications:

Complete and detailed specifications for the Repair of Hino Truck (SET-117) and Terms of Reference form part of the bidding documents.

The National Food Authority now invites eligible Bidder to tender their bids/quotations. All Quotations shall be submitted to the RBAC Secretariat, NFA Legazpi City, in two (2) separate Sealed Envelope (1-Technical component and 1-Financial component) and enclosed in a single bigger envelope properly sealed.

TERMS OF REFERENCE (TOR)

I. SCOPE OF THE CONTRACT

The NATIONAL FOOD AUTHORITY Regional Bids and Awards Committee wishes to receive bids for the Repair of HINO Truck SET-117 of NFA Sorsogon Provincial Office.

II. SOURCE OF FUND

The NFA has the Approved Budget for the Contract (ABC) for the Repair of HINO Truck SET-117 for **ONE HUNDRED THOUSAND SEVEN HUNDRED NINETY THREE PESOS (Php 100,793.00)**.

The ABC for this project is authorized per BTFMD-BUD-I-005 dated September 04, 2018.

III. ELIGIBILITY REQUIREMENTS

- (a) Duly licensed Filipino citizens/sole proprietorships;
- (b) Partnerships duly organized under the laws of the Philippines and of which at least seventy five percent (75%) of the interest belongs to citizens of the Philippines;
- (c) Corporations duly organized under the laws of the Philippines, and of which at least seventy five percent (75%) of the outstanding capital stock belongs to citizens of the Philippines;
- (d) Cooperatives duly organized under the laws of the Philippines.
- (e) Persons/entities forming themselves into a JV, i.e., a group of two (2) or more persons/entities that intend to be jointly and severally responsible or liable for a particular contract: Provided, however, that, in accordance with Letter of Instructions No. 630, Filipino ownership or interest of the joint venture concerned shall be at least seventy five percent (75%): Provided, further, that joint ventures in which Filipino ownership or interest is less than seventy five percent (75%) may be eligible where the structures to be built require the application of techniques and/or technologies which are not adequately possessed by a person/entity meeting the seventy five percent (75%) Filipino ownership requirement: Provided, finally, that in the latter case, Filipino ownership or interest shall not be less than twenty five percent (25%). For this purpose, Filipino ownership or interest shall be based on the contributions of each of the members of the joint venture as specified in their JVA.

III. OBLIGATIONS OF THE CONTRACTOR

A. Inspection, Deliveries and Start of the Contract

- a. The contractor shall conduct inspection for the Repair of HINO Truck SET-117 to gather pertinent data relative to the implementation of the project.
- b. The contractor shall strictly comply with the prescribed NFA Scope of work and specification for the Repair of HINO Truck SET-117.

- c. The contractor shall secure **Performance Security**. The performance security shall be denominated in Philippine Pesos and posted in favor of the Procuring Entity in an amount equal to the percentage of the total contract price in accordance with the following schedule:

(a) Cash or cashier's/manager's check issued by a Universal or Commercial Bank	Ten percent (10%)
(b) Bank draft /guarantee or irrevocable letter of credit issued by a Universal or Commercial Bank. Provided, however, that is shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank.	
(c) Surety Bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security; and/or	Thirty percent (30%)

- d. The contractor shall warrant the Repair of HINO Truck SET-117 under the contract to have no defects arising from the repair, and material or workmanship, or from any act or omission of the contractor that may develop under normal use.
- e. The contractor shall start the contract within 24 hours upon receipt of Notice to Proceed (NTP).
- f. The contractor shall provide a warranty period of one (1) year reckoned from the date of receipt of Final Acceptance and Certificates of the project.
- g. The contractor shall undertake repairs and servicing and shall replace the defective parts free of charge or shall repair/replace the components, if warranted, within the warranty period. The contractor shall be duly notified and shall undertake the repair/servicing within seven (7) calendar days upon receipt of the written notification.
- h. Guarantee the availability of technical/servicing personnel who shall undertake the required after-service. Further, the contractor shall positively respond to the NFA's request for service within 48-hours from the receipt of notice/request.

B. Replacement of Rejects

Should any parts be rejected, the rejected parts shall be corrected within a period of ten (10) working days after receipt of Notice of Rejection. Expenses incurred in the repair and replacement of rejected items shall be borne by the Contractor.

C. On Payments

1. The contractor shall bill **NFA Sorsogon Provincial Office** after the acceptance of the services, deliveries and compliance with the procedures provided the required documents are completely submitted.
2. Among the documents to be submitted by the contractor to NFA for payment are the following:
 - a. Letter Request for Payment
 - b. Warranty Certificate
 - c. Inspection Report
 - d. Certificate of Completion and Acceptance issued by NFA Sorsogon
 - e. Pictures (before, ongoing and upon completion)

IV. OBLIGATIONS OF NFA

1. To issue Notice to Proceed within three (3) calendar days upon approval of the contract;
2. To conduct inspection of the Repaired HINO Truck SET-117 and prepare the corresponding report. Inform the contractor in writing of defects, found in the repaired vehicle, if any and require same to correct the defects within a specific period.
3. To pay the Contractor upon submission of the following documents subject to the usual accounting and auditing rules and regulations;
 - a. Letter Request for Payment
 - b. Warranty Certificate
 - c. Certificate of Completion and Acceptance issued by NFA Sorsogon
 - d. Pictures (before, ongoing and upon completion)
 - e. Inspection Report
4. NFA shall retain from the payment of the Contractor a retention money equivalent to ten percent (10%) of the total amount due for the Contractor. The said retention money will be claimed upon exhaustion of one (1) year warranty period from the issuance of Final Acceptance.

V. TECHNICAL SPECIFICATION and SCOPE OF WORK

All materials shall conform to standards and specifications of the project.

All other items that may not be shown on the plans but are absolutely necessary for the successful completion of the project shall be considered as part of the works and shall be implemented following accepted and best engineering procedures without additional cost to NFA.

1. REPAIR OF CHASSIS & BABY CHASSIS

- i) De-rusting of chassis prior to welding of parts for repair;

- ii) Welding of parts for repair;
- iii) Splicing the damaged section by using MS Plate with 8mm thickness (see attached plans);
- iv) Secure spliced parts with bolt and nut and fully welded;
- v) Application of epoxy primer to chassis and all repaired parts;
- vi) Splicing baby chassis with 2" x 3" good lumber;
- vii) Secure it with flat bar (1/4" x 3") and bolt & nut.

2. REPAIR OF MUFFLER

- i.) Replacement of exhaust pipe;
- ii.) Repair of muffler.

3. REPAIR OF TAILGATE & FABRICATION OF MUDGUARD

- i) Replacement of damaged flat sheet of tailgate;
- ii) Replacement of damaged corrugated bar;
- iii) Realignment of bar columns;
- iv) Replacement of latches and hinges.

4. FABRICATION OF REAR BUMPER, TIRE CARRIER & BATTERY HOUSING

- i.) Fabrication of bumper using 2" x 5" channel bar with thickness of 1/8";
- ii.) Fabrication tire carrier using angle bar, 2" x 2" and 1" x 1";
- iii.) Repair of battery housing with 1" x 1" angle bar.

VI. INSPECTION

Inspection of the completed project shall be conducted by the Regional Engineer in the presence of the contractor or his authorized representative. Should any damage and/or defect be detected, the project shall not be accepted.

VII. EVALUATION AND ACCEPTANCE

The Inspection Committee shall check the performance and craftsmanship of the project and shall evaluate/assess the repaired HINO Truck SET-117 including fixtures and accessories whether it conformed to the required NFA scope of work and specifications.

The Inspection Committee shall issue a duly signed Certification on the conformity of the repaired unit and its components to the required NFA scope of work and specifications, with the recommendation for the issuance of Final Acceptance and Certificates of the project duly noted by Regional Manager.

VIII. WARRANTY

The contractor shall provide a warranty period of one (1) year reckoned from the date of receipt of Final Acceptance of the project.

IX. LIQUIDATED DAMAGES

Where the Contractor refuses or fails to satisfactorily complete the work within the specified contract time plus any time extension, the Contractor shall pay the NFA for liquidated damages and not by way of penalty, an amount as provided in the terms of reference equal to one tenth (1/10) of one percent (1%) of the cost of the unperformed portion for every day of delay. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, the Procuring Entity may rescind or terminate the contract, without prejudice to other courses of action and remedies available under the circumstances.

X. LIABILITIES OF THE CONTRACTOR

- a. It is understood that time is of the essence of the contract and in case of failure of the Contractor to comply with the terms and conditions set forth the Contractor shall be held liable in accordance with existing laws and decrees if the fault is attributed to him.
- b. No penalty for delay shall be imposed on the contractor if the cause of the delay is imputable to NFA or to any fortuitous event or force majeure. However, the contractor is still obligated to comply with the delivery of the unit and components, with no additional cost to the NFA, through out-sourcing and the delivery period shall be mutually agreed upon by both parties and an amendment to the duration of delivery or contract extension shall be executed.
- c. In case of litigation arising from the Contract, the Contractor shall pay the required litigation fees.

The case shall be filed exclusively with the proper courts in Quezon City.

XI. PROJECT DURATION

The project shall be completed within forty five (45) calendar days upon receipt of the Notice to Proceed (NTP).

XII. PAYMENT/COMPENSATION

The NFA undertakes to pay the Contractor the awarded Contract Price as stated in the Notice of Award.

Payment will be at NFA Sorsogon Provincial Office upon request of funds from BTFMD and submission by the contractor of billing statements and supporting documents subject to the usual NFA Accounting and Auditing Rules and Regulations.

The full payment shall be released after the Inspection Committee satisfactorily inspected, tested and issued Certificate of Final Acceptance of the project, and submission of all the required documents.

XIII. SPECIAL PROVISIONS

1. The retention fee amounting to ten percent (10%) of the contract price of the awarded project shall only be released by the NFA **after one (1) year reckoned from the date of receipt of Certificate of Final Acceptance of the project.**
2. The contractor shall undertake repairs and servicing and shall replace the defective parts, free-of-charge within the prescribed warranty period.
