



INVITATION TO BID

PROCUREMENT OF WAREHOUSE HANDLING (AND ALLIED) SERVICES OF NFA- CAGAYAN VALLEY REGION FOR THE PERIOD JANUARY 01 TO DECEMBER 31, 2022

1. The **National Food Authority Cagayan Valley Region**, through its **Corporate Operating Budget for the year 2021** intends to apply the sum of **Two Hundred One Million Four Hundred Nine Thousand Six Hundred Ninety Seven and 35/100 (₱ 201,409,697.35)**, being the Approved Budget of the Contract (ABC), inclusive of VAT and Social Benefits (Pag-ibig, PHILHEALTH, SSS Contributions,) other taxes and levies, to payments under the contract for **Warehouse Handling (and Allied) Services of NFA-Cagayan Valley Region**.

Bids received in excess of the ABC shall be automatically rejected.

2. The **NFA-Cagayan Valley Region** now invites bids for the **above Procurement of Warehouse Handling (and Allied) Services of NFA CVR for the period of January 01 until December 31, 2022**. Bidders should have completed, within **the last three (3) years** from the date of submission and receipt of bids, a contract similar to the Project:
 - i. a Single Largest Completed Contract (SLCC) similar in nature and complexity to the Project and the value of which, adjusted, if necessary, by the Bidder to current prices using the Philippine Statistics Authority (PSA) consumer price index, must be at least 50% of the ABC; or
 - ii. at least two (2) similar contracts with aggregate contract amounts equivalent to at least 50% percent of the ABC, the largest of which must be equivalent to at least 25% of the ABC.

Bidders should have the following qualifications:

- A. Must be owners / operators of business engaged in the warehouse handling of grains and similar services;
- B. With at least three (3) years' experience in warehouse handling of grains and similar services and was able to pay social benefits premium of its laborers whose average per year is equivalent to at least 20% of the labor requirement of this Contract for the last three (3) years preceding 2021;
- C. Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.



- Bidding will be conducted through open competitive bidding procedures using a non-Discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No.9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- Prospective Bidders may obtain further information from **NFA Cagayan Valley Region** and inspect the Bidding Documents at the address given below during **Monday to Friday at 8:00 AM to 5:00 PM**.

A complete set of Bidding Documents may be acquired by interested Bidders on **November 24 until 9:30AM of December 1, 2021** from the given address below during regular work hours, upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Pesos: **Fifty Thousand (₱ 50, 000.00)**.

It may also be downloaded free-of-charge from the websites below, subject to the payment of applicable fee for the Bidding Documents not later than the deadline of submission of bids in order to participate in the bidding process.

The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile, or through electronic means.

- The **NFA Cagayan Valley Region BAC** will hold a Pre-Bid Conference on **December 1, 2021, 1:30 PM** at the **NFA Multi-Purpose Hall, Mabini, Santiago City**, which shall be open to prospective bidders.
- Bids must be duly received by the BAC Secretariat through **manual submission** at the office address indicated below on or before, **December 13, 2021, 9:30 AM**. Late bids shall not be accepted.
- All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
- Bid opening shall be on **December 13, 2021 after the 9:30 AM deadline for the submission of bids** at the given address. Bids will be opened in the presence of the bidders’ representatives who choose to participate the activity.
- The **NFA Cagayan Valley Region** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.


