INVITATION TO BID

PROCUREMENT OF SECOND (2ND) PRIVATE MILLING SERVICES OF NFA CAGAYAN VALLEY REGION

Project Reference No. NFA-2021-RBAC-CVR-F-01

1. The **National Food Authority (NFA) –Cagayan Valley Region**, using a single-year Framework Agreement, through the **Corporate Operating Budget for the year 2021** intends to apply the sum of **Pesos: Fifty Eight Million Three Hundred Thirty Thousand Six Hundred Two (₱58,330,602.00)** as ABC exclusive of VAT, through **payment-in-kind (PIK)** scheme, representing payments for the hereunder aforesaid contract broken down of milling fees as follows:

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The **NFA Cagayan Valley Region (CVR) Bids and Awards Committee (BAC)** now invites bids for the above Procurement Project. Delivery of the Goods is required within 30 calendar days, 60 calendar days for 2 lots won by single bidder and 105 calendar days for 3 lots or more won by single bidder **after issuance of a Call- Off**.

Bidders should have completed, within the last three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders), and must have the following minimum requirements:

- a Single Largest Completed Contract (SLCC) similar in nature and complexity to the Project and the value of which it adjusted, if necessary, by the Bidder to current prices using the Philippine Statistics Authority (PSA) Consumer price index, must be atleast 50% of the ABC; or

- ii. At least two (2) similar contracts with aggregate contract amounts equivalent to at least 50% of the ABC, the largest of which must be equivalent to at least 25% of the ABC.
- iii. Ownership / operation of ricemill compliant with the following minimum required specification:

For multi-pass ricemill:

Ricemill Parameters

Classification: Multi-pass Rice Mill

Capacity: 1.5-TPH based on paddy input (minimum)

Rice Mill Equipment

- 1. Dehuller: Should be rubber-roll type
75.0% Hulling Efficiency (minimum)
- 2. Polisher: A combination of abrasive and/or Friction-type polishers
- 3. Destoner: Required

For single- pass ricemill:

Ricemill Parameters

1. Classification: Single Pass

2. Capacity: 1.0-TPH based on paddy input (minimum)

Rice Mill Equipment

- 1. Dehuller: Should be rubber-roll type
75.0% Hulling Efficiency (minimum)
- 2. Milling Degree: Can accommodate RMR and WMR

iv. with at least three (3) years experience in operating a ricemilling business with the above specifications; and

v. Have passed the latest test milling procedure conducted by the concerned Branch Office

- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No.9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 4. Prospective Bidders may obtain further information from **NFA-Cagayan Valley Regional Office** and inspect the Bidding Documents at the address given below during ***Mondays to Fridays (except holidays) at 8:00 AM to 5:00PM.***

A complete set of Bidding Documents may be acquired by interested Bidders from the given address below during regular work hours, upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of ***One Thousand (₱1,000.00) Pesos per lot.*** The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, facsimile, or through electronic means.

It may also be downloaded free-of-charge from the websites below, subject to the payment of applicable fee for the Bidding Documents not later than the deadline of submission of bids in order to participate in the bidding process.


The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile, or through electronic means.

5. The **NFA CVR BAC** will hold a ***Pre-Bid Conference on July 9, 2021; 9:00 AM*** at the NFA Multi-Purpose Hall, Mabini, Santiago City, which shall be open to prospective bidders.
6. Bids must be duly received by the BAC Secretariat through ***manual submission*** at the office address indicated below, on or before ***July 21, 2021, 9:30 AM. Late bids shall not be accepted.***
7. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause14**.
8. Bid opening shall be on **July 21, 2021, after the 9:30 AM deadline for the submission of bids** at the given address. Bids will be opened in the presence of the bidders or their representatives who choose to attend the activity.
9. The **NFA-Cagayan Valley Region reserves** the right to reject any and all bids, declare a failure of bidding or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without any liability to the affected bidder or bidders.
