## INVITATION TO BID

### SUPPLY AND DELIVERY OF FURNITURES, FIXTURES AND APPLIANCES FOR THE NEWLY-CONSTRUCTED STAFFHOUSE AT NFA CABANATUAN CITY

Delivery of services is required within the number of calendar days specified above per lot upon receipt of Notice to Proceed.

Bidders should have completed, within the last three (3) years from the date of submission and receipt of bids, a contract similar to the contract to be bid. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested bidders may obtain further information from NFA CLRO and inspect the Bidding Documents at the address given below.

Interested bidders may purchase the complete set of Bidding Documents from the RBAC Secretariat at NFA Central Luzon Regional Office (CLRO), Cabanatuan City upon payment of the corresponding **non-refundable bidding fee per lot**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the NFA website, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

The bidding activities will be conducted at the NFA-CLRO Conference Room (2nd Floor), Maharlika Highway, Cabanatuan City according to the following schedule:

Bids will be opened in the presence of bidder/s (or authorized representatives) who chose to attend the bidding. Late bids shall not be accepted.
