**CONTRACT AGREEMENT

THIS AGREEMENT made on the 3rd day of July, 2025 between **NATIONAL FOOD AUTHORITY WESTERN VISAYAS (REGION VI)**, Quintin Salas, Jaro, Iloilo City of the Philippines (hereinafter called "the Entity") of the one part and **MARINIC CONSTRUCTION SERVICES** of Brgy. Poblacion Norte, Ivisan, Capiz, Philippines (hereinafter called "the Contractor") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the **Procurement of Various Infrastructure Projects for NFA Western Visayas Rebidding (Lot 1) with Project Reference No. NFA-2024-RBAC-REGVI-016** and has accepted a Bid by the Contractor for the supply of those goods and services in the sum of **Twenty-Nine Million One Hundred Ten Thousand Seven Hundred Twenty-Nine Pesos and Sixty Centavos Only (P 29,110,729.60), inclusive of Value-Added Tax and other levies** (hereinafter called "the Contract Price") with breakdown as follows:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.


- IV. Notice of Award; and the Bidder's conforme thereto; and
- V. Other Contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of Twenty-Nine Million One Hundred Ten Thousand Seven Hundred Twenty-Nine Pesos and Sixty Centavos Only (P 29,110,729.60), inclusive of Value-Added Tax and other levies or such other sums as may be ascertained, **MARINIC CONSTRUCTION SERVICES** agrees to provide the Repair/Rehabilitation of Bolo Warehouse and increase in elevation of Bolo warehouse B and C including upgrading of the drainage system in Roxas City, Capiz in accordance with his/her/its Bid.
4. The **National Food Authority Western Visayas – Region VI** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


