## SUPPLY AND DELIVERY OF ACCESS POINT

THIS AGREEMENT, made on the \_\_\_\_\_ day of \_JUL 2 6 2023 2023 by and between:

NATIONAL FOOD AUTHORITY (NFA), a government – owned – and controlled - corporation created and existing under and by virtue of Presidential
Decree No. 4, as amended, with present office address at Visayas Avenue,
Barangay VASRA, Quezon City, represented by its Administrator, RODERICO
R. BIOCO, (hereinafter called the "Entity") of the one part, and

K2C GENERAL MERCHANDISE, a sole proprietorship duly organized and existing under and by virtue of the laws of the Philippines with office address at Zone 4 Gov. Nick Seva Street, Libon, Albay represented by its Managing Officer, MARIA CRISMA EDITHA D. MAXWELL (hereinafter called the "Supplier") of the other part.

WHEREAS, the Entity invited bids for certain goods and ancillary services, particularly for the Supply and Delivery of Access Point and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of PESOS: TWO MILLION TWO HUNDRED SEVENTY-TWO THOUSAND SEVEN HUNDRED FOUR (P2,272,704.00). (hereinafter called the "Contract Price").

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - I. Philippine Bidding Documents (PBDs);
    - . Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletin, if any
  - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents, including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- III. Performance Security;
- IV. Notice of Award of Contract; and the Bidder's conforme thereto; and
- V. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to proceed, Variation Orders, and Warrant Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of PESOS: TWO MILLION TWO HUNDRED SEVENTY-TWO THOUSAND SEVEN HUNDRED FOUR (P2,272,704,00) or such other sums as may be ascertained, K2C GENERAL MERCHANDISE agrees to supply and deliver access point in accordance with its Bid.
- 4. The NFA agrees to pay the above-mentioned sum in accordance with the terms of the negotiation.
