**INVITATION TO BID FOR THE PROCUREMENT OF NFA REGION I SECURITY SERVICES REQUIREMENT COVERING THE PERIOD
MAY 16, 2017 TO DECEMBER 31, 2017
(ITB-RBAC-ROI-2017-03-001)**

1. The NATIONAL FOOD AUTHORITY, through the 2017 Corporate Operating Budget intends to apply the sum of **SIXTEEN MILLION THREE HUNDRED TWENTY ONE THOUSAND TWO HUNDRED TWENTY TWO PESOS AND 50/100 (P16,321,222.50) ONLY**, inclusive of VAT being the Approved Budget for the Contract (ABC) to payments under the contract for the Procurement of NFA Region I Security Services. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *National Food Authority* now invites bids for the Procurement of NFA Region I Security Services¹ with the following specifications:

Delivery of the services is required from **May 16, 2017 to December 31, 2017**. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
 - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or corporations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

¹ A brief description of the type(s) of Goods should be provided, including quantities, location of project, and other information necessary to enable potential bidders to decide whether or not to respond to the invitation.

4. Interested bidders may obtain further information from NATIONAL FOOD AUTHORITY and inspect the Bidding Documents at the address given below during weekdays from 8:00AM – 5:00 PM
5. A complete set of Bidding Documents may be acquired by interested Bidders on **March 25, 2017 to April 16, 2017 weekdays only from 8:00AM – 5:00 PM and April 17, 2017 from 8:00AM – 10:00AM** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **P25,000.00**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The National Food Authority will hold a Pre-Bid Conference² on **April 03, 2017 - 10:00AM** at the NFA Regional Office I Conference Room, San Juan, La Union, which shall be open to all prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below **not later than 10:00AM on April 17, 2017**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on **April 17, 2017 – 10:01AM** at the NFA Regional Office I Conference Room, San Juan, La Union. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The National Food Authority Region I reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
