The bid shall be for the "WHOLE LOT" on "AS-IS-WHERE-IS" and "NO SELECTION" basis.

The unserviceable empty sacks maybe inspected at the above location during regular office days/hours (8:00 AM – 5:00 PM) on September 5-12, 2017. Should there be instances that the estimated weight per piece exceeds that which had been actually paid by the awardee in which case, the awardee shall be under obligation to make additional payments corresponding to the excess and to withdraw the same within the original period.

Interested bidders are required to submit the following documents during the bidding proper (Original copy and 1 certified photo copy).

1. Municipal License/Business Permit for 2017, whichever is the latest
2. Special Power of Attorney in case of representative.

All interested and qualified bidders can purchase bidding document from the Provincial Disposition Committee, NFA-Western Pangasinan Provincial Office, Lingayen, Pangasinan upon payment of non- refundable and non-transferrable bidding fee of Five Hundred Pesos (₱ 500.00) to the NFA Cashier.

Document Required for presentation before prospective bidder can buy bidding documents:

1. Municipal License/Business Permit for 2017, whichever is the latest
2. Special Power of Attorney in case of representative.

#### BID BOND AND PERFORMANCE BOND

1. The bid offer (Tender Form) must be accompanied by a bid bond equivalent to ten percent (10%) of the amount of bid/offer in the form of Cash. Cashier's/Manager's Check payable to the NFA issued any reputable commercial bank. The Cashier's/Manager's check shall be duly signed and approved by the bank manager and official receipt and machine validation of payment. Further, the Cashier's/Manager's check shall be subject for confirmation by the issuing bank before an NFA Official Receipt is issued to the bidder.
2. The application to purchase Manager's/Cashier's Check must be secured by the bidder. The application to purchase Manager's/Cashier's Check shall also be required to be submitted to the PDC Secretariat.
3. No Manager's/Cashier's Check secured and withdrawn from the account of any other person or persons submitted as bid bond by the bidder shall be accepted during the opening of bids.
4. Failure to comply with the bid bond requirement shall mean outright disqualification of the bid.
5. Forfeiture of the Bid bond shall include among others, withdrawal of bid during the period of bid validity, refusal to accept corrections or mathematical errors on bid price, refusal to accept award, etc.
6. The bid bond shall be converted to performance bond of the winning bidder.
7. The winning bidder's performance bond which is equivalent to 10% of the total amount of the unserviceable empty sacks purchased shall be released only upon completion of the withdrawal of the unserviceable empty sacks or not fully served/can no longer be served for whatever reasons, and that the winning bidder has no obligation with NFA with respect to storage fee, use of labor, transportation, equipment, etc.

Pre-bidding and Bidding proper shall be held at NFA Western Pangasinan Provincial Office, Lingayen, Pangasinan following the schedule below:
