

CONTRACT AGREEMENT

Supply and Delivery of Three (3) Units Rack Server

THIS AGREEMENT made on the 2nd day of March 2017 by and between:


NATIONAL FOOD AUTHORITY (NFA), a government owned and controlled corporation created and existing under and by virtue of Presidential Decree No. 4, as amended, with present office address at the SRA Bldg., North Avenue, Diliman, Quezon City, represented by its Administrator, **JASON LAUREANO Y. AQUINO**, and hereinafter called "the Entity" of the one part, and

INTEGRATED COMPUTER SYSTEM, INC., a corporation duly organized and existing under and by virtue of the laws of the Philippines with office address at 3F Limketkai Bldg., Ortigas Avenue, San Juan, Metro Manila represented by its Vice President – Marketing and Business Development, **MARY K. NGO**, herein referred to as the "Supplier;"

WHEREAS, the **NFA** invited Bids for certain goods and ancillary services, viz., **Supply and Delivery of Three (3) Units Rack Server** and has accepted a Bid by the Supplier for the supply of those goods in the sum of **PESOS: THREE MILLION ONE HUNDRED THIRTY SIX THOUSAND EIGHT HUNDRED SIXTY- FOUR ONLY (P3,136,864.00)** hereinafter called "the Contract Price".


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Condition of Contract referred to:
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, vis:
 - (a) the Bid Form and the Price Schedule submitted by the Supplier;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Condition of Contract; and
 - (f) the Entity's Notification of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
