The Pre-Bidding Conference and Bidding Proper (submission and opening of bids) shall be conducted at the NFA-EDO Multi-Purpose Hall, M. L. Quezon Ext., Brgy. San Roque, Antipolo City.

Interested bidders shall submit valid original and one (1) certified xerox copy of the following requirements:

- 1. Letter of Intent (LOI) to participate in the Public Bidding duly signed by the licensee or the Poultry/ Hog Raiser/ Feedmiller;
- 2. NFA Certificate of Grains Business License/Registration as Feed Miller/Poultry/ Hog Raiser and Official Receipt of payment of license/registration fee for year 2017;
- 3. Bureau of Animal Industry Certificate of Registration as feed miller or poultry/hog raiser together with Official Receipt of payment of registration fee for the current year 2017;
- 4. Valid Mayor's Permit for 2017;
- 5. ITR 2016 duly received and stamped by BIR;
- 6. Special Power of Attorney for the representative, if sole proprietorship/partnership business and/or Board Resolution or Secretary's Certificate, if Corporation/Cooperative which shall be limited to employee or immediate members of the family and official/officer/employee of the corporation authorizing said representative to represent it in all its transactions with NFA relative to the bidding;
- 7. NFA Certificate of Inspection:
 - a. minimum farm population of 1,000 heads for poultry
 - b. 100 heads for hog raising;
- 8. Barangay Certification as to existence of Poultry/ Hog Raising/ Feedmilling Business;
- 9. Sketch of location of the facility;
 - 10. Authority to allow NFA personnel to conduct verification of submitted documents and inspection of warehouse and feed mill facilities;
 - 11. Certificate of inspection of partially damaged stocks duly signed by the Warehouse Supervisor and noted by the Provincial Manager;

Only prospective bidders who submitted the complete bidding requirements and paid the bidding fees of TWO THOUSAND PESOS (P 2,000.00) for partially damaged stocks for animal feeds shall be issued the bidding documents.

Bidding should be accompanied by Bid Bond in the amount equivalent to 10% of the total amount of bid in the form of Cash /Cashier's/ Manager's Check payable to the order of the National Food Authority - East District Office issued by any reputable commercial bank. The bid bond of the winning bidder shall be converted to a Performance Bond upon issuance of the Notice of Award.
