Failure to enter into the said contract or furnish the required Performance Security shall constitute a sufficient ground for cancellation of this award and implementation of the commitments in your bid security in the form of duly notarized Bid Securing Declaration particularly, as follows:


1. The automatic disqualification from bidding for any contract with any procuring entity for a period of two (2) years upon receipt of your Blacklisting Order;
2. Payment of applicable fine equivalent to Two Percent (2%) of the Approved Budget for the Contract (ABC) within fifteen (15) days from receipt of the written demand by the procuring entity for the commission of act resulting to the enforcement of the Bid Securing Declaration under Section 40.1 of the IRR of RA 9184; without prejudice to other legal action the government may undertake.
