This Supplemental Bid Bulletin is hereby issued revising, amending and/or clarifying certain provisions of the stipulated in the Bidding Documents which was posted in PhilGEPS and NFA Website on 11 June 2025, as follows:

SECTION/ CLAUSES AFFECTED	QUERY	CLARIFICATION
Section VII. Technical Specification	Does the truck to be used in transporting the containers from the source warehouse to the vessel, and from the vessel to the destination warehouse, have any specifications or requirements?	No, there are no specifications included in Section VII of the Bidding Documents. However, Section V – Special Conditions of Contract states:  "The Contractor shall provide trucks suitable for hauling container vans, ensuring that they comply with the allowable weight capacity in accordance with RA 8794, also known as the Anti- Overloading Act. The trucks must have a valid LTFRB Certificate of Public Convenience (CPC) and be in good running condition."  Thus, it is the responsibility of the contractor to ensure that all trucks used are compliant with all applicable laws. The trucks must be LTO-registered "Truck for Hire" (TH) units, preferably 10-wheelers or 20-foot trailers, with an allowable weight capacity in accordance with RA

		The use of non-TH units will not bind the NFA to any liability from the LTO, LTFRB, or other enforcement agencies in the event of fines or penalties imposed on the trucker-contractor.
Section VII. Technical Specification	What are the capacities of the truck scales in NFA Region XII, and can they accommodate two 20-ton containers (a total of 40 tons) in a single weighing?	The truck scales at NFA Region XII have a capacity of 60 tons. This means that to prevent damage to the scales, only one 20-ton container is allowed per weighing.

The above-mentioned amendments and clarifications have been duty discussed, deliberated and resolved by RBAC XII. The said amendments and clarifications are presented during the pre-bid conference held on 19 June 2025 at Conference Room, NFA Regional Office XII, Koronadal City.

In compliance with RA 9184 and its IRR, the amendments and clarifications provided therein shall form an integral part of the pertinent Bidding Documents and related contract. Further, bidders shall be bound by the terms and conditions, otherwise any nonconformity thereof shall consider the bid as non-responsive and result to the disqualification and/or rejection of the bidder's bid.
