

Contract Agreement Form for the Design and Build for the Establishment of Modernized Warehouses in Support to Buffer Stocking Program at Various NFA Compounds of Isabela and Nueva Vizcaya Branches in Region II
(Project Identification Number 2025-09)

CONTRACT AGREEMENT

THIS AGREEMENT made this **TARLAC CITY** day of **JUL 14 2025**, 2025
between **National Food Authority with main office address at Visayas Avenue, Brgy. Vasra, Diliman, Quezon City** (hereinafter called the "Entity") and **R.D. Talens Construction & Trading, with main address at R.D. Talens Building, Maharlika Highway, Barangay Zulueta, Cabanatuan City, Nueva Ecija** (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor to execute **Design and Build for the Establishment of NFA Modernized Warehouses in Support to Buffer Stocking Program at Various NFA Compounds of Isabela and Nueva Vizcaya Branches in Region II (Project Identification Number 2025-09)** (hereinafter called "the Works") and the Entity has accepted the Bid by the Contractor in the sum of **TWO HUNDRED FIFTY-FIVE MILLION TWO HUNDRED TWENTY-EIGHT THOUSAND THREE HUNDRED TWENTY-ONE PESOS AND 48/100 ONLY (PhP255,228,321.48)** (hereinafter called "the Contract Price") for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:

- a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
- b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and




e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of TWO HUNDRED FIFTY-FIVE MILLION TWO HUNDRED TWENTY-EIGHT THOUSAND THREE HUNDRED TWENTY-ONE PESOS AND 48/100 ONLY (PhP255,228,321.48) or such other sums as may be ascertained, R.D. TALENS CONSTRUCTION & TRADING agrees to *execute and complete the Works and remedy any defects therein* in accordance with the terms of the Bidding.

4. The NATIONAL FOOD AUTHORITY agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




