



INVITATION TO BID

**PROCUREMENT OF IN-WAREHOUSE HANDLING SERVICES FOR GRAINS
OF NFA-BATANES FOR CY 2017 PURSUANT TO SECTION 10
COMPETITIVE BIDDING OF THE REVISED IRR OF RA 9184**

The NATIONAL FOOD AUTHORITY-NATIONAL CAPITAL REGION (NFA-NCR), through its Corporate Operating Budget intends to apply the Sum of **SIX HUNDRED THIRTY EIGHT THOUSAND PESOS (P638,000.00)** being the Approved Budget for the Contract (ABC) to payment under the contract for the Procurement of In-Warehouse Handling Services for Grains of NFA-Batanes for CY 2017. Bids received in excess of the ABC shall be automatically rejected at the bid opening.

The NFA-Batanes now invites bids for the **PROCUREMENT OF IN-WAREHOUSE HANDLING SERVICES FOR GRAINS OF NFA-BATANES FOR CY 2017** with the following details:

The prospective bidders must have been in the business of providing In-Warehouse Handling Services for Grains and other related or similar services within last three (3) years and must be legally, technically and financially capable to provide and undertake the handling of stocks prior to the deadline for the submission and receipt of bids; and, within the same period, have completed a single contract that provides In-Warehouse Handling Services for Grains whose value, adjusted to current prices using the National Statistics Office (NSO) consumer price indices, must be at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (Revised IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Interested bidder may obtain further information from the NFA-NCR Regional Bids and Awards Committee (RBAC) Secretariat c/o Rene T. Sarmiento and from NFA-BATANES c/o Philip Cesar Rumbaoa and inspect the Bidding Documents at the address given below during office hours from 8:00 a.m. to 5:00 p.m., Monday to Friday.

A complete set of Bidding Documents may be purchased by interested bidders starting **January 16-21, 2017 (Weekdays only 8:00 a.m. to 5:00 p.m.)** from the address below and upon payment of non-refundable Bidding Fee as stated above.


The NFA-BATANES BAC will conduct a **Pre-Bid Conference on January 23, 2017 @ 10:00 a.m.** at NFA-BATANES which shall be open to all interested parties who have purchased the Bidding Documents.

Bids must be delivered to the address below on or before **10:00 a.m., February 06, 2017**. All Bids must be accompanied by a Bid Security in the form of cash/cashier's/manager's check issued by a universal or commercial bank equivalent to 2% of ABC or in the form of Bid Securing Declaration.

Bid Opening shall be on **February 06, 2017 @ 10:00 a.m.** at NFA-BATANES. Bids will be opened in the presence of the bidder or his/her authorized representatives. Late bids shall not be accepted.

THE NATIONAL FOOD AUTHORITY-NATIONAL CAPITAL REGION RESERVES THE RIGHT TO ACCEPT OR REJECT ANY OR ALL BIDS, TO WAIVE ANY FORMALITIES OR DEFECTS FOUND THEREIN AND TO ANNUL THE BIDDING PROCESS AND REJECT ALL BIDS AT ANY TIME PRIOR TO CONTRACT AWARD, WITHOUT THEREBY INCURRING ANY LIABILITY TO THE AFFECTED BIDDER OR BIDDERS AND TO ACCEPT ONLY SUCH BIDS MOST ADVANTAGEOUS TO THE GOVERNMENT.
