The pre-bid conference and submission/opening of bids shall be conducted at NFA-Benguet Provincial Office, Loakan Road, Baguio City at the time specified above. Late bids shall not be accepted.

Hereunder are the conditions of the sale:

- 1. All interested bidders can purchase bidding documents upon payment of nonrefundable bidding fee amounting to Two Hundred Pesos Only (P 200.00) and submission of the following documents:
 - a. Valid Business/Mayor's Permit/Barangay Business Clearance for 2018
 - b. SPA for sole proprietorship or Board Resolution for corporation, in case of authorized representative
- 2. A bidder's bond equivalent to ten percent (10%) of the total value of the bid in the form of Cash, and/or Manager's/Cashier's check payable to NFA shall accompany the sealed offer. Failure to comply with the bid bond requirement shall mean outright disqualification of the bid;
- 3. The bid bond shall be converted into performance bond upon issuance of Notice of Award;
- 4. Full payment shall be made by the winning bidder within three (3) working days from the receipt of the Notice of Award. Should the buyer fails to do so, the bid bond shall be forfeited in favor of NFA without necessity of court action;
- 5. Withdrawal of the awarded junked/unserviceable properties shall be made and completed within five (5) working days from the date of payment otherwise, a daily storage fee of Php 50.00 or its equivalent shall be charged to the average of whatever balance thereof not withdrawn within the period;
- 6. In case of non-withdrawal of the winning bidder of the awarded unserviceable properties or portions thereof, the performance bond will be forfeited in favor of the NFA without the need of a court action. The NFA has the right to disqualify the winning bidder to any future bidding;
