1. Interested bidders are required to submit the following pre-qualified requirements:

- Letter of Intent to participate in the bidding.
- Mayor's / Business Permit for 2025 (Photo copy); and,
- Special Power of Attorney in case of Bidder's Representative.

Interested bidders may inspect the unserviceable empty sacks at the NFA –Magsaysay Grains Complex, Magsaysay, Bayombong, Nueva Vizcaya for Lot 01, GID 1 warehouse, San Marcos, Cabarroguis, Quirino for Lot 02, and NFA Namillangan, Alfonsolista, Ifugao for Lot3, from 8:00 AM – 5:00 PM, except Saturday and Sunday;

5. The offer shall be on **AS-IS, WHERE-IS basis, NO SELECTION basis**;

6. Sealed offers shall be accompanied with a Bid Bond in an amount equivalent to **10% of the total amount of Bid**, in the form of Cash, Cashier's or Manager's check payable to the order of NFA Nueva Vizcaya Branch Office issued by a reputable government or private commercial bank;

7. The sealed offers will be publicly opened in the presence of all Bidders/Bidder's representatives, on July 10, 2025 at the National Food Authority Nueva Vizcaya Branch Office, Capitol Compound, Bayombong, Nueva Vizcaya. **LATE BIDS SHALL NOT BE ACCEPTED**;

8. The winning bidder shall effect full payment for the awarded items **within three (3) working days** upon receipt of the **Notice of Award of Sale**, otherwise, the Bidder's bond shall be forfeited in favor of the NFA without the necessity for court action. If payment is made within the specified period, awardee's Bid Bond shall be considered as his/her Performance Bond;

9. In the event that the awardee fails to effect full payment within the prescribed period, same lot shall be awarded to the second highest bidder with the condition that the amount to be paid shall be the same as the price offered by the winning bidder;

10. The winning bidder shall withdraw the awarded items within **five (5) working days** from receipt of **Authority to Withdraw**. In case of failure to withdraw the items with the prescribed period for no valid reasons, the Awardee's Performance Bond shall be automatically forfeited without the necessity of court

action and without prejudice to legal sanctions the NFA may pursue as warranted by the situation, and may result in the Awardee's disqualification from participating in subsequent biddings;

11. All incidental expenses incurred relative to the withdrawal of the awarded items which includes but not limited to handling and hauling shall be borne by the Awardee. The NFA shall be free from any responsibility except in overseeing that the items bought by the Awardee are transferred and withdrawn orderly; and,
12. NFA officials and employees shall not be allowed, directly or indirectly, to participate in the public bidding of the above-stated properties as mandated by NFA SOP No. GS-PD-14.

The Disposal Committee reserves the right to reject any or all bids, to waive any informalities or defects found therein and accept only offers which in its judgment are most reasonable and advantageous to the Agency. The decision of the Committee as confirmed by Regional Manager II shall be deemed final.
