Specifically, Section 27.2 of R.A. 9184 states, "The bidder shall submit a Bid Securing Declaration (BSD), OR (capitalized for emphasis) any form of Bid Security in an amount not less than the required percentage of the ABC."

and

Section 39.2 of R.A. 9184 expresses, "The performance security shall be in *an amount not less than the required percentage of the total contract price* (underscoring supplied) X X X"

In case of surety bond, it should be callable upon demand issued by a surety bond or insurance company duly certified by the Insurance Commission as authorized to issue such security (underscoring supplied).
