

CONTRACT AGREEMENT

Provision of Multi-year Janitorial and Allied Services at NFA Central Office and Food Development Center Starting January 01, 2017

THIS AGREEMENT made on the 24th day of November 2016 by and between:

NATIONAL FOOD AUTHORITY (NFA), a government owned and controlled corporation created and existing under and by virtue of Presidential Decree No. 4, as amended, with present office address at the SRA Bldg., North Avenue, Diliman, Quezon City, represented by its Officer- In- Charge, **TOMAS R. ESCAREZ**, and hereinafter called "the Entity" of the one part, and


DBP SERVICE CORPORATION, a corporation duly organized and existing under and by virtue of the laws of the Philippines with office address at 2nd Floor Executive Bldg. Center, Gil Puyat Avenue, Makati City represented by its First Senior Vice President, **MR. RAUL LUIS D. MANALIGOD**, herein referred to as the "Supplier;"


WHEREAS, the NFA invited Bids for certain goods and ancillary services, viz., *Provision of Multi-year Janitorial and Allied Services at NFA Central Office and Food Development Center Starting January 01, 2017* and has accepted a Bid by the Supplier for the supply of those goods in the sum of **PESOS: TWELVE MILLION NINE HUNDRED EIGHTEEN THOUSAND FIVE HUNDRED EIGHTY FIVE & 60/100 (Php 12,918,585.60)** hereinafter called "the Contract Price".


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Condition of Contract referred to:
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, vis:
 - (a) the Bid Form and the Price Schedule submitted by the Supplier;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Condition of Contract; and
 - (f) the Entity's Notification of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
