

## CONTRACT AGREEMENT

THIS AGREEMENT made on the 17<sup>th</sup> of July, 2025 between the **NATIONAL FOOD AUTHORITY-NATIONAL CAPITAL REGION**, U.N. Avenue, Paco, Manila (hereinafter called "the Entity") of the one part and **FRV TRUCKING CORPORATION**, 3 Ilagan Street, San Francisco Del Monte, Quezon City, (hereinafter called "the Supplier") of the other part;

WHEREAS, the **NATIONAL FOOD AUTHORITY-NATIONAL CAPITAL REGION** invited Bids for certain goods and ancillary services, particularly **Trucking Services for the Transfer of 10,000 Bags NFA Rice and Various Office Supplies/Materials/Equipment from NFA-MFC Warehouse#7 to Port of Manila** and has accepted a Bid by the Supplier in the sum of Three Hundred Twenty-Five Thousand Six Hundred Pesos (**₱325,600.00**) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;  
  
Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iii. Performance Security;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of Three Hundred Twenty-Five Thousand Six Hundred Pesos (**₱325,600.00**) or such other sums as may be ascertained, **FRV TRUCKING CORP.**, agrees to the **TRUCKING SERVICES FOR THE TRANSFER OF 10,000 BAGS NFA RICE AND VARIOUS OFFICE SUPPLIES/MATERIALS/ EQUIPMENT FROM NFA-MFC WAREHOUSE # 7 TO PORT OF MANILA** in accordance with his/her/its Bid.



**WHEREAS**, the Regional Bids and Awards Committee (RBAC) delegated the conduct of the procurement of trucking services for the transfer of 10,000 bags NFA rice and various office supplies/materials/equipment from NFA-MFC Warehouse#7 to Port of Manila for CY 2025 to the **Central District Branch Office Procurement Committee (CDBOPC)**, as per RBAC Resolution No. 2025-06-09-014;

**WHEREAS**, the **Request for Quotation (RFQ)** was posted on the PhilGEPS and NFA websites, bulletin boards, and other conspicuous places from **June 18 to 24, 2025**, in accordance with the prescribed posting requirements;
