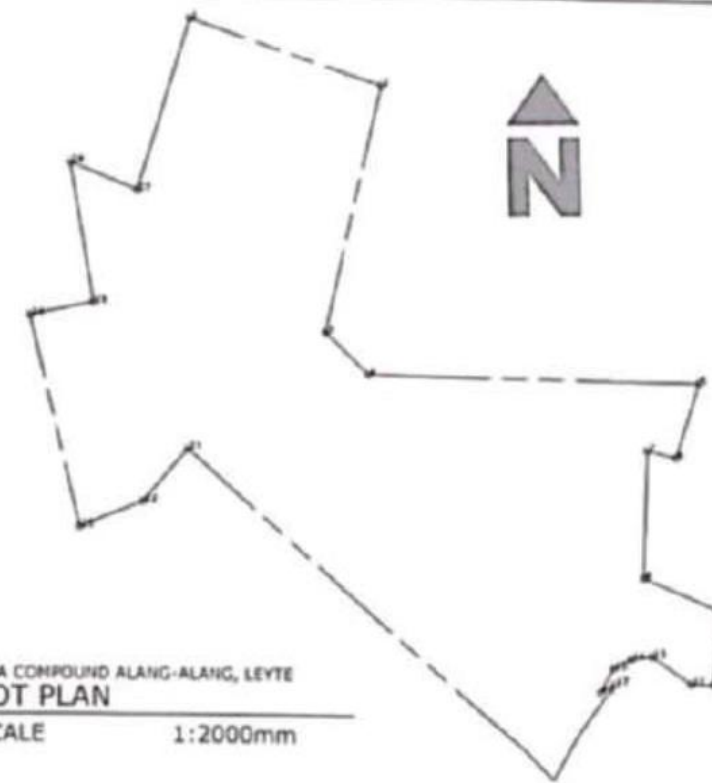

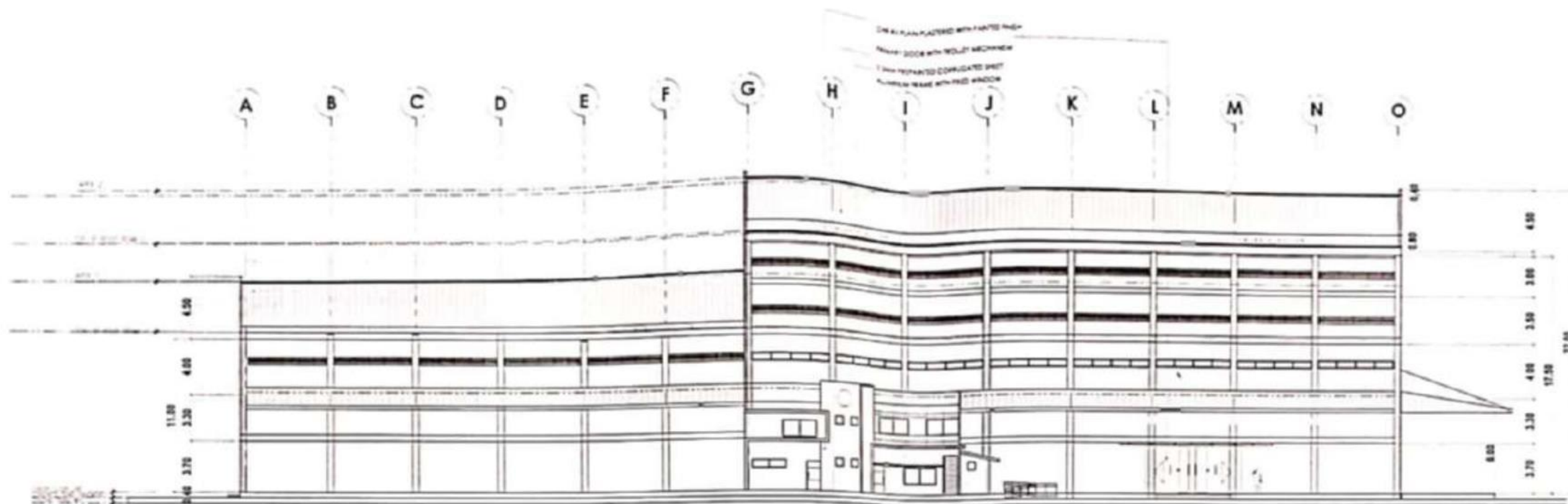

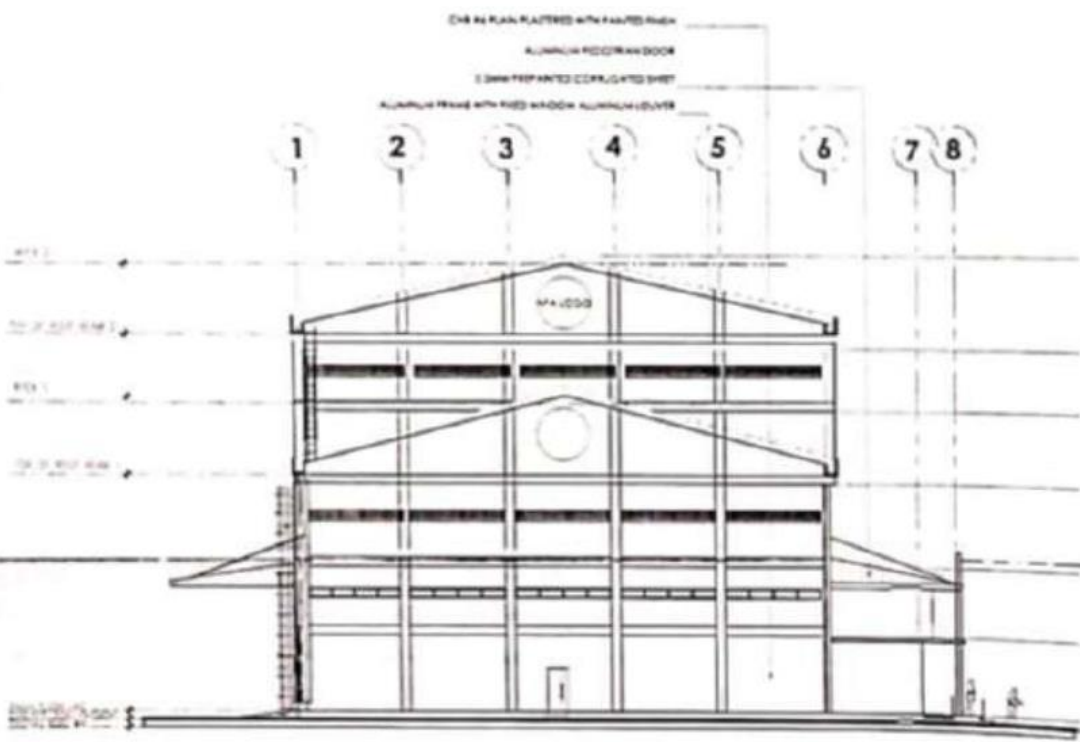
1 RIGHT SIDE ELEVATION

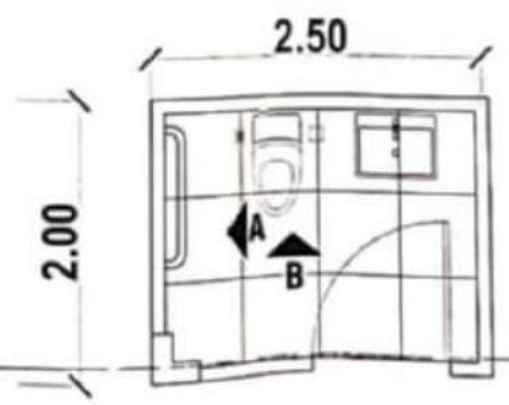
3 CROSS SECTION THRU "X"

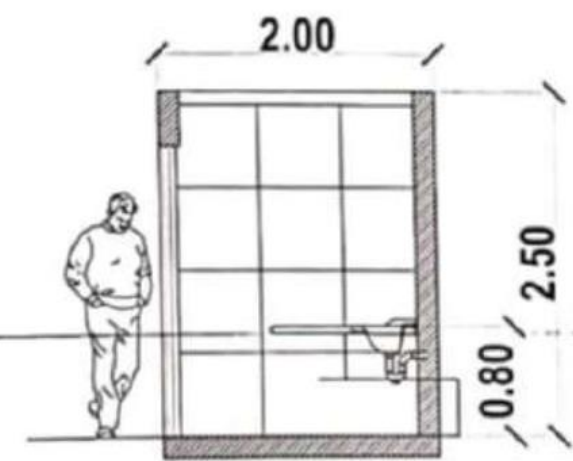
4 LABORATORY AREA

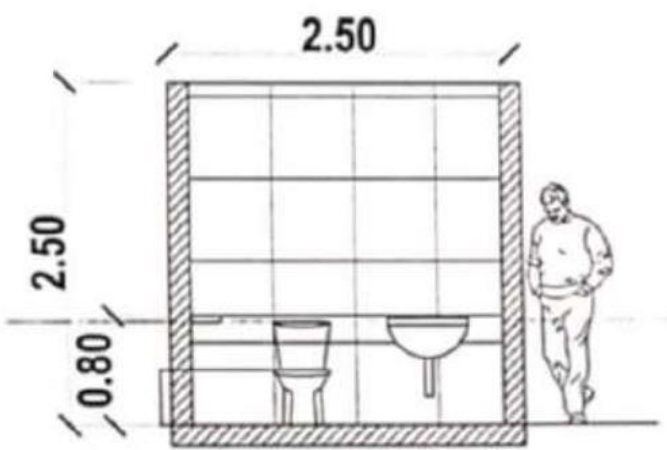
2 LEFT SIDE ELEVATION
