INVITATION TO BID

PROCUREMENT OF PRIVATE MILLING SERVICES FOR NFA DAVAO DEL NORTE AND NFA DAVAO ORIENTAL FOR THE YEAR 2025

1. The National Food Authority (NFA) - Region XI, through the Corporate Operating Budget for the year 2023 intends to apply the sum of Five Million Nine Hundred Ninety Eight Thousand Eight Hundred Sixty Pesos Only (₱ 5,998,860.00) being the ABC, through payment-in-kind (PIK) scheme to payments under the contract for the hereunder items. The payment for the milling services rendered shall be in form of rice recoveries in minimum of 63% recommended Guaranteed Milling Recovery (GMR) and the rice by-products recovered. The NFA shall pay the Miller the delivery expenses that the latter will incur in the delivery of the rice output to the NFA designated warehouse.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The **NFA-Region XI** now invites bids for the above Procurement Project. Delivery of the Goods is required upon receipt of Notice to Proceed. Bidders should have completed, within **the last three (3) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders), and must have the following minimum requirements:

- i. a Single Largest Completed Contract (SLCC) similar in nature and complexity to the Project and the value of which, adjusted, if necessary, by the Bidder to current prices using the Philippine Statistics Authority (PSA) consumer price index, must be at least 50% of the ABC; or
- ii. at least two (2) similar contracts with aggregate contract amounts equivalent to at least 50% percent of the ABC, the largest of which must be equivalent to at least 25% of the ABC.
- iii. ownership / operation of rice mill compliant with the following minimum required specification:

For multi-pass ricemill

Ricemill Parameters

1. Classification: Multi-pass Rice Mill

2. Capacity: 1.5-TPH based on paddy input (minimum)

Rice Mill Equipment

1. Dehuller: Should be rubber-roll type

75.0% Hulling Efficiency (minimum)

2. Polisher: A combination of Abrasive and/or Friction-type polishers

3. Destoner: Required

- iv. with at least three (3) years experience in operating a rice milling business with above specifications; and
- v. have passed the latest test milling procedure conducted by the concerned Branch Office.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

When two or more bidders bid on the same lot/item, the bidder with the highest offered Guaranteed Milling Recovery (GMR) will be selected.

In case a tie occurred between and/or among bidders during the opening of bids, the procuring entity will use "draw lots" to determine the winning bidder.
