## INVITATION TO BID

## [Procurement for Supply/Delivery of 2011 Pest Control Chemicals for NFA-Region VIII]

The NATIONAL FOOD AUTHORITY - REGIONAL OFFICE NO. VIII, through its Corporate Budget for 2011 intends to apply the sum of ONE MILLION ONE HUNDRED ONE THOUSAND EIGHT HUNDRED SIXTY FIVE PESOS (Php1,101,865.00) (inclusive of VAT) being the Approved Budget for the Contract (ABC) to payment under the contract for the Procurement for Supply/Delivery of 2011 Pest Control Chemicals for NFA-REGION VIII. Bids received in excess of the ABC in any or all lots, shall be automatically rejected at bid opening.

The National Food Authority, Region VIII now invites all interested reliable and efficient FPA and/or BFAD licensed manufacturer/supplier/distributor/dealer of pesticides to bid for the Supply/Delivery of 2011 Pest Control Chemicals for NFA-Region VIII. The whole requirement shall be delivered within fifteen (15) calendar days upon receipt of Notice to Proceed as contained in the Schedule of Requirement of the project. Prospective bidders should have completed within the last three (3) years from the date of submission and receipt of bids, a similar contract to the project equivalent to at least twenty-five (25%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

Bidding will be conducted through open competitive bidding using non discretionary pass/fail criteria as specified in the revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships/partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
