INVITATION TO BID

PROCUREMENT OF SECURITY SERVICES REQUIREMENT OF NFA REGION 5 COVERING THE PERIOD FROM FEBRUARY 1, 2017 TO DECEMBER 31, 2017

The **National Food Authority, Regional Office V** through its Corporate Operating Budget for 2016 intends to apply the sum of **Twenty Four Million Sixty One Thousand Nine Hundred Seventy Six Pesos and Seventy centavos (Php 24,061,976.70)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Security Services requirements of NFA Region V**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The **NFA Regional Office V**, now invites bids from **registered Security Agencies** for the Procurement of Security Services requirement of Region V. Delivery of goods is required from February 1, 2017 to December 31, 2017.

Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in **Sections II and III, Instruction to Bidders and Bid Data Sheet respectively**.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

A complete set of Bidding Documents may be purchased by interested Bidders from **January 5, 2017 (office hours only from 8 AM to 5 PM) to January 26, 2017 (from 8:00AM to 9:30AM only)** at the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of **Twenty Five Thousand Pesos (P25,000.00)**

Bids will be opened in the presence of the Bidders and/or their authorized representatives who choose to attend the bidding. Late bids shall not be accepted.
