## INVITATION TO BID

### FOR THE REPAIR OF MANGATAREM GID WAREHOUSE 1, MANGATAREM, PANGASINAN

**PROJECT REFERENCE NO.: ITB-RBAC-RO1-2017-03-005**

The National Food Authority, through its Capital Outlay Fund for 2017 intends to apply the sum of **PESOS: TWO MILLION FIVE HUNDRED SEVENTY THOUSAND FOUR HUNDRED TWENTY SIX AND 59/100 (P2,570,426.59) ONLY**, inclusive of VAT, being the Approved Budget for the Contract (ABC) to payments under the contract for the Repair of Mangatarem GID Warehouse 1 including repair of WS II office, provision of comfort room and sentry post. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The *National Food Authority* now invites bids for the Repair of Mangatarem GID Warehouse 1 including repainting, retrofitting of roof framing, roof replacement, repair of WS II office, provision of comfort room and sentry post with the following Approved Budget for the Contract and cost of bidding documents:

The prospective bidder should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II, Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from NFA Region 1 and inspect the Bidding Documents at the address given below **from 8:00 AM to 5:00 PM (March 8-27, 2017) (excluding Saturdays, Sundays and Holidays)** and **from 8:00 AM to 10:00 AM (March 28, 2017)**.

A complete set of Bidding Documents may be acquired by interested bidders on March 8, 2017 until March 28, 2017 from the address given below and upon payment of the applicable fee for the Bidding Documents pursuant to the latest Guidelines issued by the GPPB, in the amount of PESOS: Five Thousand and 00/100 (P5,000.00) only.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) ([www.philgeps.gov.ph](http://www.philgeps.gov.ph)) and the website of the National Food Authority ([www.nfa.gov.ph](http://www.nfa.gov.ph)), provided that Bidders shall pay the nonrefundable cost of Bidding Documents as stated above not later than the submission of their bids.

The bidding activities will be conducted at the **NFA Regional Office 1 Conference Room, Urbiztondo, San Juan, La Union** according to the following schedule:

Bids and eligibility requirements must be submitted to the RBAC Secretariat at NFA Regional Office I, San Juan, La Union **not later than 10:00 AM on March 28, 2017**. All bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in the Instruction to Bidders (ITB) and BDS Clause 18.1.

Bids will be opened in the presence of invited observers and to all bidder/s (or authorized representatives) who choose to attend the bidding. Late bids shall not be accepted.
