INVITATION TO BID
FOR THE CONSTRUCTION OF 100,000 CAVANS CAPACITY WAREHOUSE
WITH SUPERVISOR'S OFFICE AND SITE DEVELOPMENT
AT NFA COMPOUND IN BRGY. ISABANG, LUCENA CITY

The **National Food Authority (NFA)** Regional Office IV, through the NFA Corporate Operating Budget for 2016 intends to apply the sum of **Twenty Eight Million Six Hundred Forty Six Thousand Eight Hundred Ninety Eight Pesos and Eight Centavos (P28,646,898.08)** being the Approved Budget for the Contract (ABC) for payments under the contract for the Construction of 100,000 Cavans Capacity Warehouse with Supervisor's Office and Site Development at NFA Compound in Brgy. Isabang, Lucena City. Bids received in excess of ABC shall automatically be rejected at bid opening.

The NFA Regional Office IV, through its Bids and Awards Committee, now invites interested construction companies/contractors with PCAB Size Range Medium "A", License Category B for the Construction of 100,000 Cavans Capacity Warehouse with Supervisor's Office and Site Development at NFA Compound in Brgy. Isabang, Lucena City. Completion of works is required 180 days.

Bidders must have an experience of having completed within the last ten (10) years from the date of submission and receipt of bids, at least one (1) contract that is similar to the Project to be bid, equivalent to at least fifty percent (50%) of the Approved Budget for the Contract (ABC), adjusted to current prices using the Philippine Statistics Authority consumer price index.

The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using non discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184) otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stocks belonging to citizens of the Philippines.

Balagtas, Batangas City from **December 29, 2016 to January 30, 2017** from 8:00AM to 5:00PM (working days only) until **January 31, 2017** not later than 9:00 AM.

A complete set of Bidding Documents may be acquired by interested Bidders from the date of availability of bidding documents from **December 29, 2016 to January 30, 2017** from 8:00AM to 5:00PM (working days only) until **January 31, 2017** not later than 9:00 AM at National Food Authority, Regional Office IV, Brgy. Balagtas, Batangas City and upon payment to the NFA Cashier of a non-refundable fee for the Bidding Documents in the amount of **P 25,000.00** in the form of cash.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and NFA website, provided that bidders shall pay the non-refundable fee for the Bidding Documents pursuant to the latest guidelines issued by the GPPB not later than the submission of their bids.

The NFA Regional Office IV will hold a Pre-Bid Conference on **January 12, 2017** at 9:00 AM at NFA Regional Office Conference Room, 3rd Floor, NFA Office Building, Brgy. Balagtas, Batangas City which shall be open only to all interested parties who have purchased the Bidding Documents.

Bids must be delivered to NFA Conference Room, 3rd Floor, NFA Office Building, Brgy. Balagtas, Batangas City on or before **January 31, 2017 not later than 9:30 AM**. All bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount as indicated in the Bid Documents.


The Bid opening shall be on **January 31, 2017 at 10:00 AM** at the NFA Conference Room, 3rd Floor, NFA Office Building in Brgy. Balagtas, Batangas City. Bids will be opened in the presence of the bidder's representatives who choose to attend. Late Bids shall not be accepted.

The NATIONAL FOOD AUTHORITY REGIONAL OFFICE IV reserves the right to accept or reject any bid, to annul the bidding process and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
