## **INVITATION TO BID**

### **CONSTRUCTION OF THE NATIONAL FOOD AUTHORITY (NFA) CENTRAL OFFICE (C.O.) BUILDING** *(Public Bidding No. 2016-44)*

The **NATIONAL FOOD AUTHORITY (NFA)**, through its 2017 Corporate Budget intends to apply the sum of Four Hundred Seventy Five Million Six Hundred Fifty Four Thousand Seven Hundred Eighty Three Pesos and Forty One Centavos (Php 475,654,783.41) being the Approved Budget for the Contract (ABC) to payments under the contract for the Construction of the National Food Authority (NFA) Central Office Building. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The NFA now invites bids for the proposed eight (8) story NFA Central Office Building with basement parking and a functional roof deck with a total building area of 16,431.05 square meters to be constructed in the 9,000 square meter NFA-owned lot located along Visayas Avenue, Quezon City. Completion of the Works is required within three hundred ninety five (395) days from receipt of the winning bidder of the Notice to Proceed. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is indicated in the Bidding Documents, particularly, in Section II. Instructions to Bidders (ITB).

Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

A complete set of Bidding Documents may be acquired by interested Bidders starting **December 20, 2016 until January 11, 2017 from 8:00am to 2:00pm and on January 12, 2017, at least 30 minutes before the opening of bids at the BAC Secretariat Office, 3<sup>rd</sup> Floor, NFA Central Office**, upon payment of the bidding documents fee in the amount of **Seventy Five Thousand Pesos (Php 75,000.00)** in accordance with the latest Guidelines issued by the GPPB.

It may also be viewed or downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PHILGEPS) and from the NFA website, provided, that bidders shall pay the non-refundable fee for the bidding documents prior to submission of their bids.

The venue of bidding activities shall be at the **NFA Function Hall, 7<sup>th</sup> Floor Sugar Center Bldg., North Avenue, Diliman, Quezon City**. Schedule of activities are as follows:

Bids will be opened on the scheduled date/time at the venue specified above in the presence of the Bidders or their authorized representatives who choose to attend the bidding. Late Bids shall not be accepted.

The **NATIONAL FOOD AUTHORITY** reserves the right to accept bids most advantageous to the government or reject any Bid, to annul the bidding process and reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder/Bidders.
