The prospective bidders must have been in the business of manufacturing/supplier/distributor/dealer of pesticides for the last three (3) years prior to the deadline for the submission and receipt of bids; and, within the same period, have completed a single contract that is similar to the contract to be bid, and whose value, adjusted to current prices using the National Statistics Office (NSO) consumer price indices, must be at least twenty five percent (25%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (Revised IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Interested bidder may obtain further information from the NFA-NCR Regional Bids and Awards Committee (RBAC) Secretariat c/o Rene T. Sarmiento and inspect the Bidding Documents at the address given below during office hours from 8:00 a.m. to 5:00 p.m., Monday to Friday.

A complete set of Bidding Documents may be purchased by interested bidders starting March 01-20, 2017 (Weekdays only 8:00 a.m. to 5:00 p.m.) from the address below and upon payment of non-refundable Bidding fee in the amount stated above.

The NFA-NCR RBAC will conduct a **Pre-Bid Conference on March 08, 2017 @ 1:30 p.m.** at 3rd Floor of J. Dela Cruz Hall, NFA-NCR which shall be open to all interested parties who have purchased the Bidding Documents.

Bids must be delivered to the address below on or before 1:30 p.m., March 21, 2017. All Bids must be accompanied by a Bid Security in any of the applicable forms and in the amount indicated in Section 27 of the Revised IRR of RA 9184.

Bid Opening shall be on March 21, 2017 @ 1:30 a.m. at 3rd Floor of J. Dela Cruz Hall, NFA-NCR. Bids will be opened in the presence of the bidder or his/her authorized representatives. Late bids shall not be accepted.
